**COMMISSION STAFF'S PROPOSED DATES FOR THE HEARING ON THE MERITS**

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Commission Staff's Proposed Dates for the Hearing on the Merits. In support thereof, Staff shows the following:

**I. BACKGROUND**

On September 30, 2015, J. Hinken (Complainant) filed a complaint against Bastrop West Water and its owner, Paul Klaus (BWW) pursuant to Texas Admin. Code § 22.242 (TAC). On November 9, 2015, the Commission referred this case to the State Office of Administrative Hearings (SOAH). On June 1, 2016, SOAH Order No. 6 set the hearing on the merits for October 19-20, 2016. SOAH Order No. 12 granted the unopposed motion to reschedule the hearing on the merits and ordered parties to provide additional proposed dates for resetting the hearing.

**II. MOTION TO RESCHEDULE THE HEARING ON THE MERITS**

Staff has conferred with Complainant and BWW and proposes the following dates for the hearing on the merits: January 13, 2017; January 30, 2017; and January 31, 2017; with January 13, 2017 being the preferred date. Staff believes one day will be sufficient to hear this case, and no party has expressed opposition to that position.


