### COMMISSION STAFF'S RECOMMENDATION ON NOTICE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Recommendation on Notice. In Support thereof, Staff shows the following:

#### I. BACKGROUND

On September 30, 2015, the City of Edinburg (Edinburg) and North Alamo Water Supply Corporation (North Alamo WSC) (collectively, Applicants) filed with the Public Utility Commission of Texas (Commission) a joint application (Application) to amend Edinburg's water certificate of convenience (CCN) No. 12106 and to decertify a portion of North Alamo WSC's water CCN No. 10553 in Hidalgo County. The amendment will enable Edinburg to include approximately 40 acres of land and zero current customers.

Order No. 7 instructed Staff to file a recommendation on notice by June 24, 2016.

#### II. RECOMMENDATION

Staff recommends that no notice needs to be issued at this time. If the Staff ultimately makes a recommendation for the Application to be approved and the Commission finds that the Application should be approved, the Applicant should issue notice pursuant to TWC § 13.255(c) at that time,

Consistent with Order No. 7, Staff will make its next recommendation on July 25, 2016.


**CONCLUSION**


