COMMISSION STAFF'S REQUEST FOR ADDITIONAL TIME

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for Additional Time. In Support thereof, Staff shows the following:

I. BACKGROUND

On September 30, 2015, the City of Edinburg (Edinburg) and North Alamo Water Supply Corporation (North Alamo WSC) (collectively, Applicants) filed with the Public Utility Commission of Texas (Commission) a joint application (Application) to amend Edinburg's water certificate of convenience (CCN) No. 12106 and to decertify a portion of North Alamo WSC's water CCN No. 10553 in Hidalgo County. The amendment will enable Edinburg to include approximately 40 acres of land and zero current customers.

Order No. 9 instructed Staff to file a joint proposed notice of approval by September 20, 2016.

II. REQUEST FOR ADDITIONAL TIME

Staff requests until October 3, 2016 for the parties to file a joint proposed notice of approval. Staff needs additional time to work with the Applicants to help draft a joint proposed notice of approval. Staff conferred with the City of Edinburg and North Alamo WSC, and neither party objects to this request.



CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request.
