**ORDER NO. 6
REQUIRING CLAIRIFICATION FROM COMMISSION STAFF**

This Order requires Commission Staff's to clarify its May 16, 2016 recommendation that the proof of notice provided by the applicants on April 28, 2016 is sufficient and to correct or confirm its proposed procedural schedule. The April 28, 2016 proof of notice provided by applicants includes an affidavit of notice to neighboring utilities, customers and affected parties that includes a list of the individuals to which notice of this application was sent and attests to notice being provided by the City of Copperas Cove on April 20, 2016. However, affidavits of the individual notices sent indicate that the notice to current customers, neighboring systems and cities was mailed on April 22, 2016. Therefore, Commission Staff shall clarify the last date on which notice of this application was provided, April 20, 2016 or April 22, 2016.

Additionally, Commission Staff included August 9, 2016 as the 120-day notification period deadline for the Commission to approve the sale administratively or request a hearing, as provided in 16 TAC § 24.109(e). However, the 120th day from April 20, 2016 is Thursday, August 18, 2016. Likewise, the 120th day from April 22, 2016 is Saturday, August 20, 2016. Therefore, for all the reasons stated in this Order, on or before May 25, 2016, Commission Staff shall provide the requested clarification regarding the last date of notice and correct or confirm its proposed procedural schedule.
