

COMES NOW the Staff of the Public Utility Commission of Texas ("Staff"), representing the public interest, and Kempner Water Supply Corporations (Kempner) and the City of Copperas Cove (Copperas Cove) (together the "Applicants"), and file this Joint Proposed Notice of Approval and Motion to Admit Evidence in response to Order No. 11 and would show the following:

I. BACKGROUND

On September 30, 2015, the Applicants filed with the Public Utility Commission of Texas ("Commission") an application for the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Phase 2. Section 2 of the Skyline Flats Subdivision located in Coryell County, Texas

On September 25, 2017, Order No. 11 was issued establishing a deadline of October 20, 2017, for the Parties to file a joint proposed notice of approval and request to admit evidence. Accordingly, this pleading is timely filed

II. MOTION TO ADMIT EVIDENCE


