# COMMISSION STAFF'S RESPONSE TO ROCKY CREEK'S REQUEST FOR EXTENSION OF TIME

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Commission Staff's Response to Rocky Creek's Request for Extension of Time, and would show the following:

#### I. BACKGROUND

On October 7, 2015, Rocky Creek Manor Subdivision (Applicant) filed with the Public Utility Commission of Texas (Commission) an application (Application) for exempt utility registration pursuant to Texas Water Code § 13.242(c) (TWC) and 16 Tex. Admin. Code § 24.103(d) (TAC). In Order No. 2, issued November 5, 2015, the Administrative Law Judge (ALJ) found the Application deficient and set a deadline of December 11, 2015, for Rocky Creek to cure the noted deficiencies and file a supplemental application. On December 14, 2015, Rocky Creek filed a Letter Regarding Request for Additional Time. Pursuant to the deadlines established in Order No. 2, this pleading is timely filed.

### II. COMMISION STAFF'S RESPONSE AND PROPOSED SCHEDULE

Staff has been in contact with Rocky Creek and supports an extension of time to allow for the Applicant to fully cure and supplement the Application. Staff recommends that the Applicant be allowed until January 15, 2016 to cure the noted deficiencies, and that Staff be allowed until February 16, 2016 to file a supplemental recommendation.

#### III. CONCLUSION

Staff respectfully requests the Administrative Law Judge issue an order consistent with the above recommendations.
