



# SOAH ORDER NO. 1 GRANTING MOTION TO WITHDRAW, DESCRIPTION OF CASE, SCHEDULING PREHEARING CONFERENCE, AND GENERAL PROCEDURAL REQUIREMENTS

#### 1. Motion to Withdraw

On January 6, 2016, Tony Corbett filed a Motion to Withdraw as Co-Counsel for Trophy Club Municipal Utility District No. 1. The motion is GRANTED.

## 2. Description of Case

On October 9, 2015, residents of the Trophy Club Municipal Utility District No. 1 (Ratepayers) filed a petition appealing the decision of the board of directors of Trophy Club Municipal Utility District No. 1 (District) affecting the rates charged for water, sewer, base, and volumetric, which were effective on September 1, 2015.

On January 11, 2016, the Commission referred this case to the State Office of Administrative Hearings (SOAH), requesting the assignment of an administrative law judge (ALJ) to conduct a hearing and issue a proposal for decision, if such is necessary. SOAH has jurisdiction over matters relating to the conduct of the hearing in this proceeding under Texas Government Code § 2003.049.

### 3. Scheduling of Prehearing Conference

The ALJ will convene a telephone prehearing conference at 10:00 a.m., on Thursday, March 3, 2016. At the prehearing conference, the ALJ will address a procedural and discovery
