COMMISSION STAFF'S SUPPLEMENTAL PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files Commission Staff's Supplemental Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On October 14, 2015, Woodland Hills Water, LLC (Woodland Hills) filed an application to amend its water certificate of convenience (CCN) No. 12388 in Liberty and Montgomery Counties, Texas.

Order No. 17, issued October 17, 2017, required Woodland Hills to file required Texas Commission on Environmental Quality (TCEQ) approvals by November 22, 2017. On November 17, 2017, Woodland Hills filed the necessary TCEQ approvals. Order No. 17 also established a deadline of December 6, 2017 for Staff to file a supplemental recommendation and supplemental procedural schedule. Therefore, this pleading is timely filed.

II. SUPPLEMENTAL PROCEDURAL SCHEDULE

On November 27, 2017 Staff provided final maps, a certificate, and a tariff to Woodland Hills for review and consent. Staff proposes the following procedural schedule for the continued processing of this matter:

Event	Date
Deadline for Woodland Hills to file signed consent forms with the Commission	December 15, 2017
Deadline for Staff to file a final recommendation	December 22, 2017
Deadline for parties to file joint proposed findings of fact and conclusions of law	January 8, 2018


