### COMMISSION STAFF'S SUPPLEMENTAL FINAL RECOMMENDATION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files Commission Staff's Supplemental Final Recommendation. In support thereof, Staff shows the following:

On October 14, 2015, Woodland Hills Water, LLC (Woodland Hills) filed an application to amend its water certificate of convenience (CCN) No. 12388 in Liberty and Montgomery Counties, Texas.

Order No. 18, issued December 7, 2017, required Staff to file a final recommendation by December 22, 2017. On December 20, 2017, Staff filed its Final Recommendation, which included final maps, certificate and tariff. Attachment B to the Final Recommendation should have include three different maps; however, only one map was included. Staff now supplements its filing to include the correct Attachment B.

### II. CONCLUSION

Staff recommends this application be approved. Pursuant to Order No. 18, Staff will work with Woodland Hills to file proposed findings of fact, conclusions of law, and ordering paragraphs by January 8, 2018.

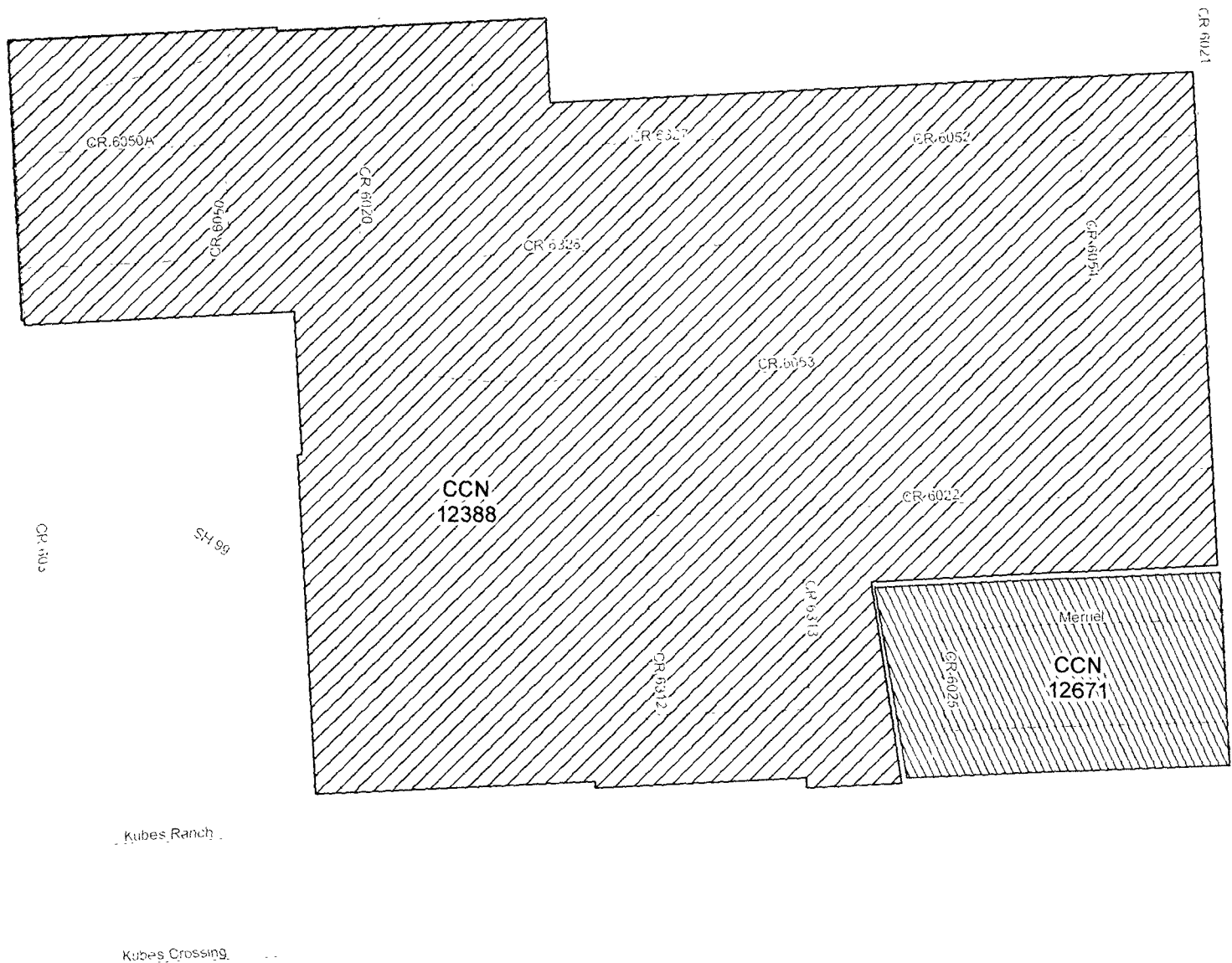

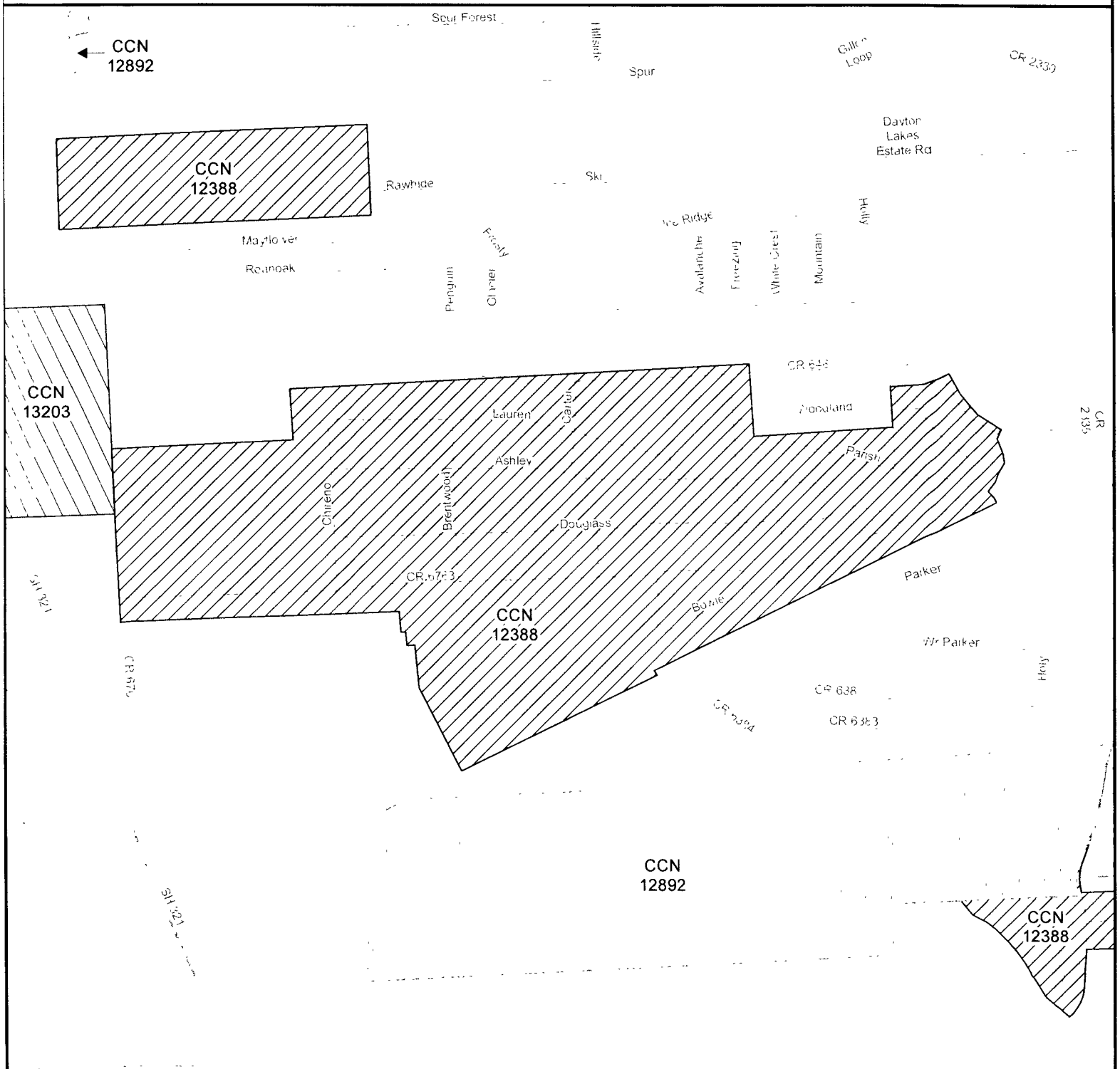
