COMMISSION STAFF'S ADDITIONAL PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Order No. 10 and Additional Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On October 21, 2015, Zipp Road Utility Company, LLC (Zipp Road) filed with the Commission an application to obtain a new sewer certificate of convenience and necessity (CCN) in Guadalupe County. On September 1, 2016, Zipp Road filed a letter regarding a settlement with Guadalupe-Blanco River Authority (GBRA), where Zipp Road will plan on receiving wholesale wastewater service from GBRA while remaining the retail provider. On September 9, 2016, Zipp Road filed revisions to its CCN application to account for this change and GBRA filed a motion to withdraw its opposition to the amended application. In Order No. 10, issued September 30, 2016, Staff was ordered to file a supplemental recommendation by December 2, 2016. This pleading is therefore timely filed.

II. ADDITIONAL PROCEDURAL SCHEDULE

Staff is prepared to begin final mapping for the CCN area and recommends the following procedural schedule be adopted:

Event	Date
Deadline for Staff to provide final map, certificate, and tariff to Applicant for review and consent	December 7, 2016
Deadline for Applicant to file signed consent forms with the Commission	December 21, 2016
Deadline for Staff to file a final recommendation on the Application	January 6, 2016
Deadline for parties to file joint proposed findings of fact and conclusions of law	January 13, 2016
