#### NORTH SAN SABA WATER SUPPLY CORPORATION'S LIST OF ISSUES

North San Saba Water Supply Corporations (NSSWSC) hereby submits the following list of issues in response to the Public Utility Commission's January 11, 2016 Order of Referral.

#### I. Issues to be Addressed

- 1. What information was available to the NSSWSC Board of Directors at the time it made its decision to increase the water utility service rates?
- 2. What criteria were considered by the NSSWSC Board of Directors in setting the rate increase?
- 3. Based on the information available to the NSSWSC Board of Directors at the time it made its decision to increase water utility service rates effective September 15, 2015 and the criteria considered, are the rates fixed by the NSSWSC just and reasonable and compliant with the standards set forth in Tex. WATER CODE § 13.043(j) and P.U.C. SUBST. R. 24.41(i)?
- 4. Should the NSSWSC Board of Directors have fixed different water utility service rates effective September 15, 2015?
- 5. If the NSSWSC Board of Directors should have fixed different water utility service rates effective September 15, 2015, what are those rates that the Commission should now fix in this proceeding?

- 6. What methodology should the Commission use to fix water utility service rates for NSSWSC while preserving NSSWSC's financial integrity?
- 7. What are the reasonable expenses incurred by NSSWSC in this proceeding?
- 8. How should NSSWSC recover its reasonable expenses incurred in this proceeding from its ratepayers?

#### II. Conclusion

NSSWSC respectfully requests that the Commission adopt NSSWSC's list of issues and grant NSSWSC such other relief to which it may be justly entitled.
