Dear Members,

On August 11, 2015, at a regular meeting of the Board of Directors for the North San Saba Water Supply Corporation, the Board voted to change the water rates. As stated in our letter dated July 17, 2015 the water system's expenses are exceeding revenues.

The effective date of the rate change was September 15, 2015 (when the meters were read) and will be reflected on the bill you receive on or about October 28, 2015 which will be due on November 15, 2015.

The new rates are as follows:

Monthly Rate	\$ 82.00 per month – Residential \$400.00 per month – Commercial
1 to 4,000 gallons of water	\$ 2.70 per thousand gallons
4,001 to 8,000 gallons of water	\$ 5.07 per thousand gallons
8,001 to 20,000 gallons of water	\$ 7.09 per thousand gallons
20,001 gallons or more of water	\$ 9.46 per thousand gallons

The Board of Directors meets regularly on the second Tuesday of each month at 5:30 in the Arrowhead Bank Board Room on the second floor. Your attendance is welcomed.




