For convenience, below is a texted-document listing of the names of those Members of the North San Saba Water Supply Corporation who have signed the Board-sponsored petition, and indicating their support of the NSSWSC Board's position in the matter of PUCT Docket#45283. The actual signed petition sheets are attached. It is understood by all that this petition has no force of law under Texas Water Code 13.043, as did the original petition which necessitated opening this case. Instead, the intent of this petition is to demonstrate, as a matter of moral balance, that at least as many Members support the Board's action, as do not. The petition reads as follows:

<u>Summary</u>
