
Before me, the undersigned authority, on this day personally appeared George Freitag, a person whose identity is known to me, who having by me first duly sworn state on his oath as follows:

"My name is George Freitag, and I am the Texas Regulatory Manager for SouthWest Water Company, parent of Monarch Utilities I, L.P. I am capable of making this affidavit. I am over 21 years of age, have personal knowledge of the facts herein set out, and am fully qualified to make this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct."

- 1. Monarch Utilities I, L.P. primary business is providing water and wastewater utility services and is the service provider of water and wastewater for various service areas in the State of Texas including but not limited to Polk County, Texas.
- 2. On October 18, 2016 the water service area of Romark Utility Company (Oak Terrace Estates Subdivision) was transferred to Monarch by final Order of the Public Utility Commission of Texas in Docket Number 45317.
- 3. Monarch Utilities I, L.P. provides retail water utility service to Oak Terrace Estates under CCN No. 12983 and Romark no longer provides retail water service to the area.
- 4. A certified map showing the utility service areas under Monarch's Certificate of Convenience and Necessity No. 12983 ("CCN") service area in Polk County was previously filed in the Real Property Records, Polk County, Texas (2007-1551-685 to 688).
- 5. This affidavit contains as an attachment the certified map showing the utility's water service area and boundary description in Polk County, Texas.
- 6. This affidavit is being filed and recorded in the Real Property Records of Polk County, Texas, pursuant to Section 13.257 (r) and (s) of the Texas Water Code.




