#### Written description of the proposed service area boundary following verifiable and manmade landmarks (November 16, 2015):

Beginning at the centerline of F.M. 2147, approximately 1,700 l.f. (0.32 mile) west of the intersection of Hedges Drive and F.M. 2147, extending south approximately 1,900 I.f. (0.36 mile) along the west property line of the Mike Kelley tract, thence, east approximately 2,060 l.f. (0.39 mile) along the south property line of the Castle Terrace subdivision, thence, north approximately 60 l.f. (0.01 mile) along the east property line of the Castle Terrace subdivision, thence, east approximately 400 l.f. (0.08 mile) along the south property line of the Castle Terrace subdivision; thence south approximately 1,950 I.f. along the west property line of Darrell W. and James A. Agnew's tract; thence east approximately 2,122 l.f. along the south property line of the Darrell W. and James A. Agnew's tract; thence south approximately 580 I.f. along the west property line of the Darrell W. and James A. Agnew's tract; thence east approximately 2,446 l.f. along the south property line of the Darrell W. and James A. Agnew's tract; thence north approximately 4,272 l.f. along the east property line of the Darrell W. and James A. Agnew's tract to the south ROW line of FM 2147; thence east approximately 2,750 I.f. along the south curved ROW line of F.M. 2147; thence north approximately 4,870 l.f. along the east property line of the Lois W. Anderson tract to the center of Lake Marble Falls; thence west along the curved centerline of Lake Marble Falls approximately 10,700 l.f.; thence south approximately 150 l.f. to the south shore of Lake Marble Falls; thence south approximately 2,000 l.f. along the west property line of the LBJ Yacht Club tract to the tract's southwest corner; thence, east along the south shoreline of Lake LBJ approximately 2,400 l.f.
