COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Supplemental Recommendation on Administrative Completeness. In Support thereof, Staff shows the following:

#### I. BACKGROUND

On November 23, 2015, Ranch Utilities, L.P. (Ranch Utilities) and EMCAD Water and Wastewater, LLC (EMCAD) (jointly Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate of convenience and necessity rights in Parker County. Specifically, <u>EMCAD</u> seeks approval to acquire a portion of the sewer systems assets of <u>Ranch Utilities</u> held under sewer Certificate of Convenience and Necessity (CCN) No. 21064 in the Sugar Tree Subdivision.<sup>1</sup> On January 19, 2016, Applicants filed supplemental information in response to Order No. 2.

On February 25, 2016, Staff filed its comments on the administrative completeness of the application, proposed notice, and a procedural schedule. Staff's Supplemental Recommendation on Administrative Completeness provides the affidavits of notice that were inadvertently omitted from Staff's Recommendation on Administrative Completeness. Therefore, this pleading is timely filed.

## II. COMMENTS ON ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum of Andrew Novak and Kristy Nguyen, in the Commission's Water Utilities Division, Staff finds the Applicants have cured all application and

notice deficiencies. Therefore, Staff recommends the application be deemed administratively complete pursuant to 16 Tex. Admin. Code §§ 24.109 and 24.112 (TAC).

The Commission's notice requirements for STM applications are provided by 16 TAC § 24.112. Specifically, Staff recommends the Applicants be directed to provide the attached notice to the following:

- a) any districts, groundwater conservation districts, counties, utilities, cities, cities with an extraterritorial jurisdiction within two miles of the proposed service area;
- b) any city with an extraterritorial jurisdiction which overlaps the proposed service area;
- c) any customers transferred, or other affected parties in the requested area;
- d) notice to the public which must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Parker County; and
- e) notice to the county judge of each county and to each groundwater conservation district that is wholly or partly included in the area proposed to be certified.

Applicants should notify the following entities in addition to the neighboring entities listed in its application: Upper Trinity Groundwater Conservation District.

Additionally, Staff recommends Applicants be ordered to include a copy of a map showing the proposed service area with the individual notices to neighboring utilities and other affected parties. Information related to districts including addresses can be obtained from the TCEQ web site located at <a href="http://www.14.tceq.texas.gov/iwud/">http://www.14.tceq.texas.gov/iwud/</a>.

### III. PROPOSED PROCEDURAL SCHEDULE

Staff recommends the following procedural schedule:

On November 24, 2015, Ranch Utilities, L.P. (Ranch Utilities) and EMCAD Water and Wastewater, LLC (EMCAD) (Collectively, Applicants) filed an application with the Public Utility Commission of Texas (Commission) for sale, transfer, or merger (STM) of facilities and in Parker County. Specifically, EMCAD seeks approval to acquire a portion of the sewer system assets and service area of Ranch Utilities held under sewer Certificate of Convenience and Necessity (CCN) No. 21064 in the Sugar Tree Subdivision. Upon approval of the application EMCAD will amend EMCAD's existing CCN No. 20816 to include the Sugar Tree Subdivision.

Order No. 2, issued by the Commission, deemed the application insufficient for filing and afforded the Applicants until January 29, 2016 to cure the noted deficiencies in the application. Order No. 2 also afforded Commission staff until February 25, 2016 to file a supplemental recommendation on administrative completeness.

After reviewing the application, Staff recommends the application be found administratively complete and sufficient for filing.

Furthermore, Staff recommends the Applicants be ordered to do the following:

- 1. In addition to those entities listed in the application, provide notice to the following entities located within a 2-mile buffer of the proposed service areas:
  - a) Upper Trinity Groundwater Conservation District
- 2. Provide notice of the application to the following entities:
  - a) any districts, groundwater conservation districts, counties, utilities, cities with an extraterritorial jurisdiction within two (2) miles of the proposed service areas;
  - b) any city with an extraterritorial jurisdiction which overlaps the proposed service areas;

- c) any customers transferred, or other affected parties in the requested area;
- d) notice to the public which must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Parker County; and
- e) Notice to the county judge of each county and to each groundwater conservation district that is wholly or partly included in the area proposed to be certified.
- 3. Include a copy of a map showing the proposed service areas with the individual notices to neighboring utilities, customers and other affected parties. It is the Applicant's burden to provide an accurate map delineating the proposed service areas with each individual notice. Information related to districts including addresses can be obtained by the Applicant from the TCEQ web site located at <a href="http://www14.tceq.texas.gov/iwud/">http://www14.tceq.texas.gov/iwud/</a>.
