### FINAL MAP AND REVISED CERTIFICATE


**COMES NOW** the Commission Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Order No.7:

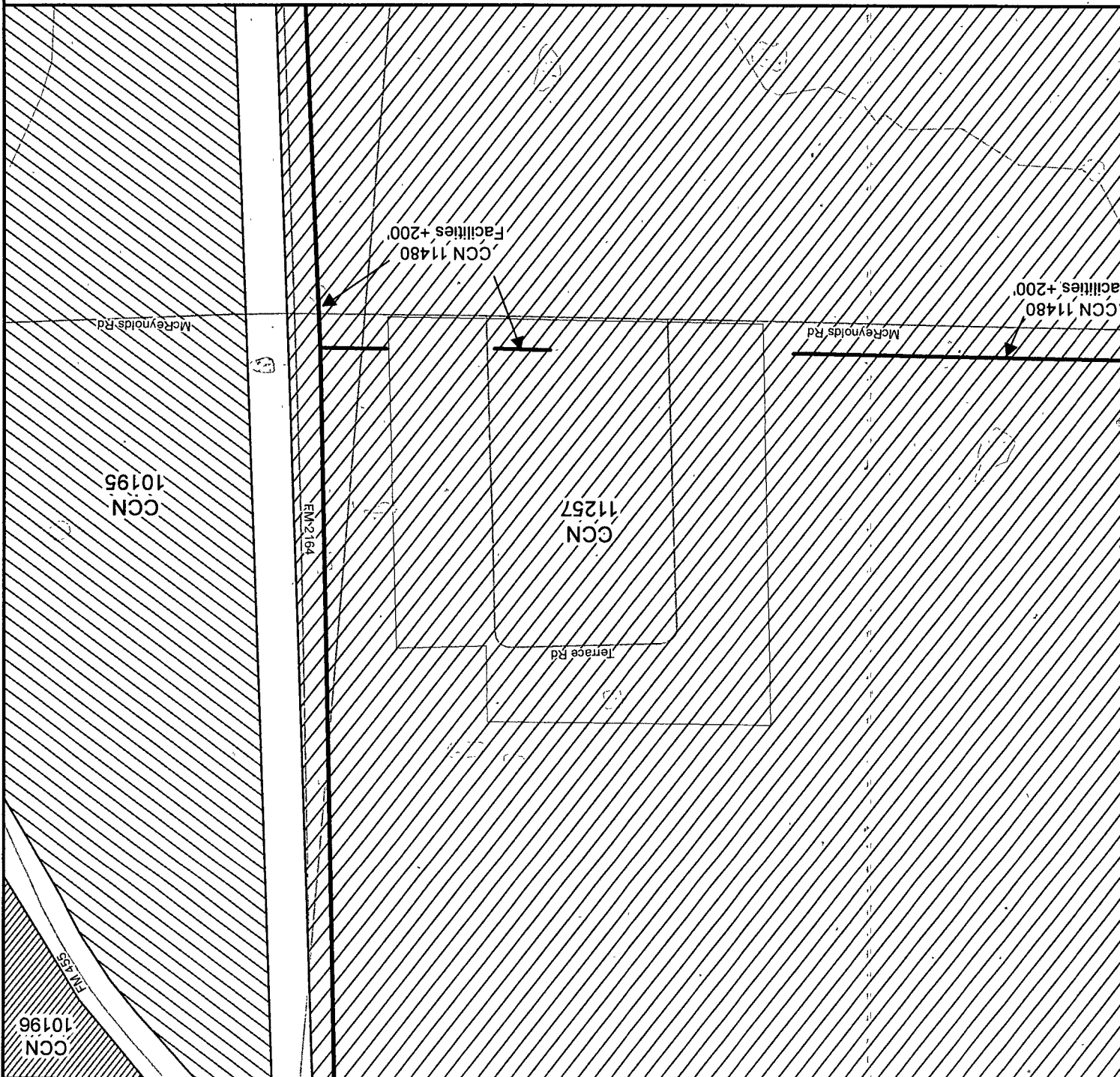
