ORDER NO. 2 FINDING APPLICATION ADMINISTRATIVELY COMPLETE; REQUIRING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On November 30, 2015, Terrace Acres Water Supply Corporation (Terrace Acres WSC) and Bolivar Water Supply Corporation (Bolivar WSC) (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Denton County. Applicants seek approval of a transaction in which Bolivar WSC will acquire all of Terrace Acres WSC's certificated service area under water certificate of convenience and necessity (CNN) No. 12323 in Denton County, and associated facilities. Bolivar WSC's CCN No. 11257 will be amended.

III. Administrative Completeness

On December 30, 2015, Public Utility Commission of Texas (Commission) Staff recommended the application be found administratively complete. Consistent with Commission Staff's recommendation, the application is administratively complete.

IV. Notice

Commission Staff also recommended that Applicants be instructed to provide notice consistent with the instructions in the attached memorandum of Jolie Mathis and Tracy Montes of the Commission's Water Utility Regulation Division, using attached forms. Consistent with Commission Staff's recommendation, Applicants shall provide notice of this application consistent with the instructions and using the forms provided by Commission Staff. Applicants shall file proof of completion of notice by the deadline set forth below.

V. **Procedural Schedule**

Commission Staff also proposed a procedural schedule for continued processing of this application. Accordingly, the following procedural schedule shall apply:

Deadline for Applicants to file affidavits of proof of notice	January 27, 2016
Deadline for intervention; deadline for intervenors to request a hearing on the merits	30 days after Applicants mails or publish notice, whichever occurs later
Deadline for Staff to file an additional procedural schedule for the remainder of the proceeding	February 17, 2016
