COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas, representing the public interest, and files Commission Staff's Proposed Procedural Schedule in response to Order No. 2 and would show the following:

I. Background

On November 30, 2015, Terrace Acres Water Supply Corporation (Terrace Acres WSC) and Bolivar Water Supply Corporation (Bolivar WSC) (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Denton County. Applicants seek approval of a transaction in which Bolivar WSC will acquire all of Terrace Acres WSC's certificated service area under water certificate of convenience and necessity (CNN) No. 12323 in Denton County, and associated facilities. Bolivar WSC's CCN No. 11257 will be amended.

In Order No. 2, issued January 4, 2015, the Administrative Law Judge (ALJ) found the application to be administratively complete and ordered Staff to file an additional procedural schedule for the remainder of the proceeding by February 17, 2016. Therefore, Staff's proposed schedule is timely.

II. Proposed Procedural Schedule

Staff proposes the following procedural schedule:

Deadline for intervention; deadline for intervenors to file comments or request a hearing on the merits.	Monday, February 8, 2016 ¹
Deadline for Staff to request a hearing or file a recommendation on approval of the sale and on the CNN amendment.	Tuesday, April 5, 2016
Deadline for parties to file a response to Staff's recommendation.	Tuesday, April 19, 2016
Expiration of 120-day deadline for Commission action on STM (approval or denial of sale/transfer to proceed) pursuant to 16 Texas Administrative Code § 24.109(e) (TAC). ²	Tuesday, May 3, 2016

If the Commission ALJ determines on or before May 3, 2016 that the STM should be approved, Staff will at that point propose additional dates for the processing of this docket, such

¹ Pursuant to 16 TAC 24.106(a)(3), the intervention deadline is 30 days after the mailing of notice. Notice was mailed on January 8, 2015. Thirty days after January 8, 2016 is Sunday, February 7, 2016. The next working day is Monday, February 8, 2016.

² Pursuant to 16 TAC 24.109, the deadline for Commission action is 120 days after the later of either when the application is filed, when notice was mailed, or when notice is published. One hundred and twenty days after January 4, 2016 is Tuesday, May 3, 2016.

as deadlines for signed sales documents to be submitted, submittal of a final recommendation by Staff, and submittal of a joint proposed order.

III. Conclusion

Staff recommends that Staff's proposed procedural schedule be adopted.
