I recommend making the following change to the proposed order. Finding of fact 11 should be modified to add areas that are included in the supplemental map provided by the City of Gregory.

11. The requested area generally consists of the area within Gregory's municipal boundaries and a portion of Gregory's extraterritorial jurisdiction as well as an area outside of the extraterritorial jurisdiction in which Gregory provides water and sewer service.

Also, I propose delegating to Commission Advising and Docket Management staff the authority to modify the order to conform to the Citation and Style Guide for the Public Utility Commission of Texas and to make other non-substantive changes to the order for such matters as capitalization, spelling, grammar, punctuation, style, correction of numbering, and readability.

I look forward to discussing this matter with you at the open meeting.
