To summarize our conversation this morning:

1. New digital data needs to be created and filed with the PUC. It should be a single polygon projected .shp or projected .dwg of the proposed area, which in this case will be the City of Gregory ETJ boundary *minus* the existing City of Portland CCN (please find existing City of Portland attached in this email).
2. New maps (both large scale and small scale) need to be created and filed with the PUC. They should show the boundary of the proposed area from #1 above. The city limits should not be shown on the map, only the proposed area. The proposed area should be labeled as 'Proposed Area', instead of ETJ.

Mr. Castaneda,

It was good to talk with you today, thanks for your time. Below is a summary of the topics we covered during our phone conversation.

First, if it is City of Gregory's intention to use their ETJ boundaries as the proposed CCN area, then the City of Gregory's proposed water and sewer CCN areas appear to overlap City of Portland's existing water CCN 10541 and sewer CCN 20216. This needs to be resolved by removing the portions from the proposed which overlap with the existing CCN's. Once this is fixed in the digital data, then file the new digital data with the PUC, as well as updated large and small scale maps which have the fixed proposed CCN area clearly labeled or included in a legend.

Second, if it is City of Gregory's intention to use their ETJ boundaries as the proposed CCN area, then the City of Gregory's proposed water and sewer CCN areas appear to overlap City of Portland's proposed water and sewer CCN areas (pending in Docket 45781).

As we discussed, the options for City of Gregory are:

- Intervene in Docket 45781 (City of Portland), through the Public Utility Commission,
- Contact City of Portland to negotiate the overlapping proposed boundaries, or
- Remove the portions of City of Gregory's proposed CCN which overlap City of Portland's proposed CCN

I've attached shapefiles of the existing City of Portland CCN's (water 10541, sewer 20216). Please feel free to contact me with any questions.
