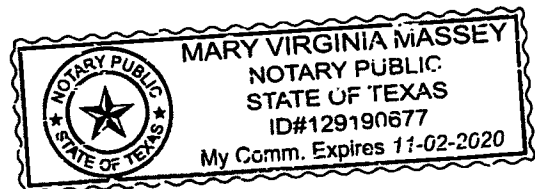

1. A strange or unusual odor in the vicinity of a pipeline.

2. A hissing or roaring sound (caused by natural gas or product escaping from a pipeline).
3. Flames originating from an opening in the ground.
4. Bubbles or sheen on the water.
5. If you become aware of a pipeline leak:
⇒ LEAVE AREA IMMEDIATELY!
⇒ Avoid driving near escaping gas.
⇒ Avoid direct contact with the escaping gas or liquids.
⇒ Avoid creating sparks or sources of heat which could cause the natural gas to ignite and burn. If you find yourself in a suspected gaseous area, do not light a match, start an engine, or even switch on an electric light.
