ORDER NO. 13 ESTABLISHING DEADLINE FOR APPLICANT TO CURE DEFICIENCIES AND STAFF'S RECOMMENDATION

This Order addresses the City of Gregory's response to Commission Staff's recommendation to dismiss this docket. On June 12, 2017, Commission Staff stated that Gregory's mapping information remained deficient and that Gregory had not provided adequate information demonstrating the need for service, therefore, Staff motioned for dismissal of this application for failure to prosecute. According to the memorandum of Sean Scaff and Gary Horton of the Commission's Water Utilities Division, attached to the June 12th recommendation, Gregory's amended map does not reflect the Port of Corpus Christi Authority's opt-out request and does not meet the requirements for final approval. To date, Gregory's mapping documents remain deficient.

On July 12, 2017, the engineer for the City of Gregory filed a letter protesting Staff's recommendation that the application be dismissed. It appears that Gregory needs additional time to work with Staff to rectify misunderstandings regarding Commission's mapping requirements. Therefore, the City of Gregory will be given 30 days to work with Commission Staff and is encouraged to consult with Water Utilities Staff by telephone to complete the mapping requirements. Gregory shall notify the ALJ and identify any difficulties hindering the progress to provide final maps by August 14, 2017.

On or before August 14, 2017, the City of Gregory shall file the final maps and all information as recommended in Staff's recommendation of May 10 and June 12, 2017, in order to complete this application, as a motion to dismiss remains pending. Gregory shall remove all optout requests, including the request of the Port of Corpus Christi Authority, and submit mapping and digital data for the territory that remains in the service area.

No later than September 6, 2017, Commission Staff shall file a recommendation on Gregory's attempt to cure the remaining deficiencies. If any deficiencies exist at that time, Commission Staff shall list the deficiencies to aid the City of Gregory in filing a complete application.
