



DEFINITIONS

- A. "Gregory," or "you" refers to the City of Gregory and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B. - Staff 2-2** Does the City have the capability to serve customers in the ETJ area outside of the City limits?
- Staff 2-3** If the City has received requests for service in its ETJ and does not currently have infrastructure in those areas, has the City submitted plans and specification to the TCEQ for the additional facilities necessary to serve the requested area?
- Staff 2-4** Please provide the most current audited financial statements, including the auditor's report/opinion letter.
