SOAH ORDER NO. 2  
MEMORIALIZING PREHEARING CONFERENCE AND  
ESTABLISHING SECOND PREHEARING CONFERENCE

I. JULY 12, 2018 PREHEARING CONFERENCE

On July 12, 2018, the first prehearing conference in this docket convened telephonically to determine the status of the case and establish additional procedures. The staff (Staff) of the Public Utility Commission of Texas and representatives of the City of Gregory, including the Mayor, were in attendance. To proceed, it was determined that at least an additional map is needed showing all of the service area that the City of Gregory seeks to certify, including potential new northern development in the City of Gregory city limits and extra-territorial jurisdiction. The parties agreed that the City of Gregory would provide a map (or maps) to Staff on or before Wednesday, July 18, 2018 that clearly depicts where and how this potential northern development fits within all of the service territory that the City of Gregory seeks to certify in this docket. A second prehearing conference would then be convened telephonically on Tuesday, July 24, 2018 to discuss how to proceed once Staff has had an opportunity to consider the map(s). The Administrative Law Judge (ALJ) encourages the City of Gregory or its representatives to contact Staff prior to July 18, 2018, *if necessary*, to ensure that the forthcoming map(s) provide the information that Staff needs to proceed.

Accordingly, it is ordered that the City of Gregory shall provide to Staff on or before **July 18, 2018** a map or maps of depict the service territory that it seeks to be covered by a certificate of convenience and necessity in this docket as discussed at the July 12, 2018 prehearing conference.

## II. NOTICE OF TELEPHONIC PREHEARING CONFERENCE


