ORDER NO. 4 APPROVING INTERIM RATES

This Order addresses the joint motion for the approval of interim rates filed on April 20, 2016. Commission Staff and Rankin Park request approval of the interim minimum bill and gallonage rates to be charged by Rankin Park beginning May 1, 2016. Draft tariff sheets were attached to the joint motion.

According to the motion, approval of the interim rates would reduce the extent of or possibly eliminate the need for any refund that may be credited to Rankin Park's customers based on the difference between Rankin Park's proposed rates and the rates that will ultimately be adopted in this proceeding. Commission Staff and Rankin Park propose that Rankin Park provide notice to its customers with the first billing at the interim rate consistent with Commission rules.

The joint request for approval of interim rates is granted. The interim rates, consistent with the attached draft tariff sheets, are approved. Rankin Park shall provide notice to customers consistent with Commission rules.
