METHOD USED TO ALLOCATE UTILITY CHARGES

Occupancy and size of rental unit ¹⁵ ~~25~~ percent (in which no more than 50%) of the utility bill for water/wastewater consumption is allocated using the occupancy method checked above. The remainder is allocated according to either:

- the size of the space rented by the tenant of a manufactured home divided by the size of all rental spaces.
