ORDER NO. 1 GRANTING MOTION TO SEVER AND SEVERING AND DOCKETING APPLICATION TO OBTAIN A SEWER CERTIFICATE OF CONVENIENCE AND NECESSITY

This Order addresses the motion of Old Tamina Water Supply Corporation (Old Tamina WSC) to sever the application to obtain a sewer certificate of convenience and necessity (CCN) in Montgomery County. In its original application Old Tamina WSC is seeking to amend its water CCN No. 12289 for a dual certification with the City of Shenandoah (Shenandoah) and obtain a new sewer CCN. Old Tamina WSC stated it is currently engaged in litigation with Shenandoah preventing it from continuing forward with the amendment to the water CCN and dual certification and that further delays in obtaining the sewer CCN jeopardizes a United States Department of Agriculture grant and loan package. Old Tamina WSC stated the application to obtain the sewer CCN is a complete application and can be processed as a standalone application.

On May 13, 2016, Commission Staff recommended severing the application to obtain a new sewer CCN from the application for dual certification of a water CCN and assigning the application a new docket number.

Accordingly, Old Tamina WSC's motion to sever is granted and issues related to the application of a new sewer CCN are severed into the following docket: *Application of Old Tamina Water Supply Corporation to Obtain a Sewer Certificate of Convenience and Necessity in Montgomery County (37616-C)*, Docket No. 45988. Within 15 days of this order, Old Tamina WSC and Commission Staff shall, and any other interested party may, identify all parts of the record pertaining to the application to obtain a new sewer CCN and file this information in Docket No. 45988.

On or before **June 3, 2016**, Old Tamina shall amend its application to obtain a new sewer CCN to cure the deficiencies described by Commission Staff in its filing on May 13, 2016 and the memorandum of Debbie Reyes Tamayo, Andrew Novak, and Tracy Montes of the Commission's Water Utility Regulation Division. Processing of the application cannot proceed until the requested items are received and reviewed. On or before **June 24, 2016**, Commission Staff shall file additional comments regarding administrative completeness, along with a proposed procedural schedule, if deemed administratively complete.
