OLD TAMINA WATER SUPPLY CORPORATION'S STATUS REPORT

NOW COMES Old Tamina Water Supply Corporation ("Old Tamina") and hereby files its March 1, 2017 Status Report in compliance with the Administrative Law Judge's (ALJ) Order No. 6 Abating Proceeding.

In Order No. 6, the ALJ granted Old Tamina's request to abate this proceeding until litigation between Old Tamina and The City of Shenandoah ("Shenandoah") is resolved.

As of today's date, a settlement has been reached between Old Tamina and Shenandoah, and the litigation has been resolved pending final execution of documents and the filing of an Agreed Motion to Dismiss with the court.

Shenandoah City Council voted to approve the settlement at its February 22, 2017 meeting. Consistent with the settlement terms, on February 28, 2017, Shenandoah emailed to Old Tamina letters granting consent and approval for Old Tamina's applications for dual certification water and sewer certificates of convenience and necessity ("CCN"s) overlapping Shenandoah's existing CCNs. (Copies of the letters are attached hereto as "Exhibit 1" and "Exhibit 2".) By the terms of the settlement, Shenandoah must deliver to Old Tamina a copy of the official approved city council

minutes documenting the council's approval of the settlement. Shenandoah has stated that the minutes will be formally approved and delivered to Old Tamina on or before March 23, 2017. Old Tamina will file for dismissal of the lawsuit within 3 days after delivery.

The lawsuit was pending before the 284th Judicial District Court of Montgomery County, Texas, and was set for trial on March 6, 2017. The court has been notified of the settlement and has removed the trial from its calendar pending completion of the settlement. The court has reset the case for a status check for dispositive documents on March 24, 2017.




