APPLICATION OF OLD TAMINA WATER SUPPLY CORPORATION TO AMEND ITS WATER CERTIFICATE OF CONVENIENCE AND NECESSITY FOR DUAL CERTIFICATION WITH THE CITY OF SHENANDOAH IN MONTGOMERY (37615-C)

OLD TAMINA WATER SUPPLY CORPORATION'S STATUS REPORT

NOW COMES Old Tamina Water Supply Corporation ("Old Tamina") and hereby files its April 1, 2017 Status Report in compliance with the Administrative Law Judge's (ALJ) Order No. 6 Abating Proceeding.

In Order No. 6, the ALJ granted Old Tamina's request to abate this proceeding until litigation between Old Tamina and The City of Shenandoah ("Shenandoah") was resolved.

The litigation has been fully resolved. The parties have fully executed settlement documents, and Old Tamina has filed a dismissal of the lawsuit with the court of jurisdiction.

Shenandoah delivered to Old Tamina written consent for dual certification as required for both Old Tamina's water and sewer CCN applications. The written consent letters were filed with Old Tamina's March 1, 2017 Status Report. In addition, the sewer dual certification consent letter was filed in Docket 45988 as required to complete Old Tamina's sewer CCN application.

Old Tamina respectfully requests that its amended water CCN application in Docket No. 45552 remain severed and abated from its sewer CCN application in Docket 45998. This request is made because of the imminent threat of the de-obligation of the \$2.2 million USDA Rural

Development loan and grant that was awarded to Old Tamina contingent upon acquisition of its sewer CCN. Old Tamina has submitted all items required for completion of its sewer CCN application and requests that the sewer CCN application process be allowed to proceed as expeditiously as possible.


