JOINT MOTION TO LIFT ABATEMENT AND APPROVE PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and Old Tamina Water Supply Corporation (Old Tamina WSC), and file this Joint Motion to Life Abatement and Approve Procedural Schedule.

I. Background

On May 15, 2013, Old Tamina WSC filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12289 for a dual certification with the City of Shenandoah (Shenandoah) and obtain a new sewer CCN in Montgomery County with the Texas Commission on Environmental Quality (TCEQ).¹ On May 27, 2016, the Administrative Law Judge (ALJ) issued Order No. 1 granting Old Tamina WSC's Motion to sever the application to obtain a sewer CCN from the water CCN application for dual certification.

On June 1, 2016, Order No. 6 was issued granting Old Tamina WSC's request to abate the proceeding until litigation between Old Tamina WSC and Shenandoah was resolved. On March 3, 2017, Old Tamina WSC filed the required written consent from Shenandoah for the dual certification for the portion of Old Tamina WSC's proposed water CCN service area overlapping with Shenandoah's water CCN No. 13146. On April 6, 2017, Old Tamina WSC filed a status report indicating that the litigation between Old Tamina WSC and Shenandoah had been resolved, the parties had executed settlement documents, and Old Tamina WSC has filed for a dismissal of the lawsuit.




