6) For a proposed wastewater rate increase, the notice shall include a billing comparison showing the existing rate and the new computed sewer rate using 5,000 gallons and 10,000 gallons, unless the utility proposes a flat rate for wastewater services. If the proposed wastewater rate will be based on a winter months' average, the notice shall list the months to be used when computing that average and shall state the rates that will be charged to customers until a winter months' average is available for those customers that have not yet established a winter months' average.

7) Proof of notice in the form of an affidavit stating that proper notice was mailed, e-mailed or delivered to customers and affected municipalities and stating the date(s) of such delivery, shall be filed with the Commission by the applicant utility as part of the RFP.
