### SOAH ORDER NO. 4 CONFIRMING INTERVENORS; GRANTING MOTION TO LIFT ABATEMENT; SETTING NEW SCHEDULE AND HEARING DATES

On June 24, 2016, Monarch Utilities I, L.P. (Monarch) filed a motion to lift the period of abatement, adopt a proposed procedural schedule, and grant interim rates. The Administrative Law Judges (ALJ) find merit in the motion, which is GRANTED as set out below.

The ALJs have reviewed the service list and Order No. 2 and found that three ratepayers requesting intervention were added to the service list (and therefor received Order Nos. 2 and 3) but were not listed as intervenors in Order No. 2. These are ratepayers are added to the list: Jerry Batt, David Norris, and Douglas Penland.

# Notice of Settlement Conference

A mandatory settlement conference will convene on:

August 10, 2016, at 10:00 a.m. State Office of Administrative Hearings (SOAH) William P. Clements Office Building 300 West 15th Street, Fourth Floor Austin, Texas

Subject to the mediator's directives, attendance is mandatory for all parties. The parties, however, are not required to settle and may send a representative to the mediation with authorization to settle on their behalf. In the event the parties want a SOAH mediator, the Staff of the Public Utility Counsel of Texas shall file a request for the assignment of a SOAH mediator **no later than July 11, 2016**. It is the ALJs' understanding that, absent a SOAH mediator, Staff will be conducting the mediation at SOAH. If this is incorrect, the ALJs shall be notified by July 11, 2016.

#### **Granting Interim Rates**

No party objected to Monarch's motion for interim rates. Accordingly, Monarch's motion is GRANTED. Effective September 1, 2016, Monarch's current water and wastewater rates will be set as interim rates pursuant to Texas Water Code § 13.187(l) until the Commission sets final rates. Monarch SHALL timely file its interim tariff pages with the Commission's docket clerk.
