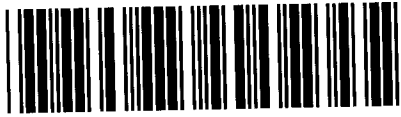

MONARCH UTILITIES I, L.P.'S PROOF OF NOTICE BY AFFIDAVIT

Monarch Utilities I, L.P., ("Monarch") files its Proof of Notice by Affidavit and states as follows:

Monarch filed a Rate Filing Package on February 29, 2016 with the Public Utility Commission of Texas. Under 16 Tex. Admin. Code § 24.22(b)(5) and (c) ("TAC"), notice to customers, affected municipalities, and the Office of Public Utility Counsel ("OPUC") of an application to change rates pursuant to Texas Water Code § 13.187 shall be by mail, email, or hand delivery. On February 29, 2016, Monarch provided to OPUC by hand delivery a copy of its application to change rates. Additionally, on February 29, 2016, Monarch delivered copies of its application to change rates by certified mail return receipt requested to all affected municipalities. Monarch mailed notice to all customers on February 29, 2016, meeting all the necessary requirements under 16 TAC § 24.22(c)(1). A copy of the Affidavit of Provision of Notice verifying the mailing of the notice to customers is attached hereto.





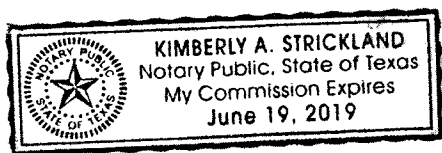
