



# MONARCH UTILITIES I, L.P.'S MOTION TO GRANT INTERIM RATES

Monarch Utilities I, L.P.'s, ("Monarch") files this Motion for Interim Rates, which Public Utility Commission ("Commission") Staff and the Office of Public Utility Counsel ("OPUC") support, and respectfully shows the following:

#### I. BACKGROUND

On February 29, 2016 Monarch filed its application to change rates for water and sewer service. On June 24, 2016 Monarch, with the consent of the intervening parties, filed its "Motion to Lift Discovery and Procedural Schedule Abatement and Grant Interim Rates." On July 1, 2016, in SOAH Order No. 4, the Administrative Law Judges ("ALJs") granted Monarch's request for interim rates, ordering that effective September 1, 2016, Monarch's current water and sewer rates would be set as interim rates pursuant to Texas Water Code § 13.187(l) until the Commission sets final rates.

On September 9, 2016, prior to the conclusion of the hearing on the merits, all parties to the proceeding reached a unanimous settlement agreement and reported to the ALJs that the parties agreed on the terms of the settlement. One of the terms was that to implement the agreed-upon revenue requirements for water and sewer service, Monarch would request interim rates to be effective October 1, 2016. Another agreed term was that a surcharge for service during the month of September would be imposed in the interim rate order to make the new interim rates relate back to September 1, 2016.

### II. GRANTING OF INTERIM RATES & RELEVANT SURCHARGE

Pursuant to the settlement agreement reached by the parties on September 9, 2016, the parties have agreed to interim rates, as set forth in Exhibit "A" to this motion, to be put into effect October 1, 2016. According to 16 Tex. Admin. Code ("TAC") § 24.29(b), "[a]fter a hearing is convened, any party may petition the judge or Commission to set interim rates." As a result Monarch, in conjunction with Commission Staff and OPUC, respectfully requests that an order be entered declaring that, effective October 1, 2016, water and sewer rates as set out in Exhibit "A" be set as interim rates pursuant to Tex. Water Code § 13.187(1), until such time that the Commission sets a final rate.

Consistent with 16 TAC § 24.29(i), Monarch can be authorized by the Commission to collect from its customers the difference between final rates and the interim rates. Monarch has calculated the difference between the interim rates set pursuant to SOAH Order No. 4, which were charged to customers beginning September 1, 2016, and those that are requested to be authorized pursuant to this motion per each individual customer billed usage. Because the requested interim rates are the same as the agreed-upon final rates, Monarch, in conjunction with Commission Staff and OPUC, requests that the ALJs authorize the recovery of such difference through a surcharge to be added to the customers' November utility bill, as calculated in Exhibit "B" to this motion. The differences shown in Exhibit "B" can be applied to each customer's September bill and provide a surcharge tailored to each customer.

#### III. PRAYER

Wherefore, premises considered, Monarch, joined with Commission Staff and OPUC, respectfully requests that an order declaring that, effective October 1, 2016, the water and sewer rates as recommended in Exhibit "A" be set as interim rates pursuant to Tex. Water Code § 13.187(1), until such time that the Commission sets a final rate, authorizing the recovery of the

difference between interim rates set pursuant to SOAH Order No. 4 and the interim rates established pursuant to this motion through a surcharge to be added to customers' November utility bill, and granting any other relief to which Monarch shows that it is justly entitled.

#### SEASONAL RECONNECTION FEE

Base rate for meter size times number of months off the system not to exceed six months when leave and return within a twelve-month period.

#### LINE EXTENSION AND CONSTRUCTION CHARGES:

Refer to Section 2.12 Specific Utility Service Rules and Section 3.02 Utility Specific Exténsion Policy for terms, conditions, and charges.

#### GOVERNMENTAL TESTING, INSPECTION AND COSTS SURCHARGE CLAUSE:

Increases in inspection fees and water testing costs imposed by state or federal law may be passed through as an adjustment to the monthly base rate charge under the terms and conditions of 30 TAC 291.21(k)(2) after notice to customers and upon written approval by the PUC.

## SUPPLEMENTAL EMERGENCY SERVICE FEE

Applicable to nonresidential water service customers that require supplemental service over and above their existing water service from time to time. Usage to be determined by customer. The minimum diameter for supplemental service meter shall be 2 inches.

## SECTION 1.0 - RATE SCHEDULE (Cont.)

PURCHASED WATER AND/OR DISTRICT FEE PASS THROUGH CLAUSE – ALL WATER SUPPLY SUBJECT TO FEE:

Changes in fees imposed by any non-affiliated third party water supplier or underground water district having jurisdiction over the Utility shall be passed through utility-wide as an adjustment to the water gallonage charge according to the following formula:

AG = G + B/(1-L), where

AG = adjusted gallonage charge, rounded to the nearest one cent:

G = approved gallonage charge (per 1,000 gallons);

B = change (per 1,000 gallons) due to purchased water/district

gallonage changes; and

L = system average line loss for preceding 12 months not to exceed 0.15.

# PURCHASED WATER AND/OR DISTRICT FEE PASS THROUGH CLAUSE – PORTION OF WATER SUPPLY SUBJECT TO FEE:

Upon notice from a water supplier of either an increase or decrease in the cost of purchased water, the Utility shall provide notice to customers and the Commission of its intent to implement rates imposed by any non-affiliated third party water supplier or underground water district having jurisdiction over the Utility shall be passed through Utility-wide as an adjustment to the water gallonage charge according to the following formula:

Adjustment to the gallonage rate = AG = (CP/GB) x 1,000 Adjustment to the minimum bill = AMB = GMB x AG

 $CP = CP_1 - CP_0 =$  change in cost of purchased water;

CP1 = Cost of purchased water during the most recent 12 month period at the new rate;

CPo = Cost of purchased water during the most recent 12 month period at the previous rate;

GMB = Number of gallons in the minimum bill, divided by 1,000; and

GB = Number of gallons billed to customers in excess of the amount included in the monthly minimum bill for the 12 month period used above.

# SECTION 1.0 - RATE SCHEDULE (Cont.)

## TEMPORARY WATER RATE:

Unless otherwise superseded by PUC order or rule, if the Utility is ordered by a court or governmental body of competent jurisdiction to reduce its pumpage, production or water sales, the Utility shall be authorized to increase its approved gallonage charge according to the formula:

TGC = cgc + (prr)(cgc)(r)

(1.0-r)

Where:

TGC = temporary gallonage charge;
cgc = current gallonage charge;
r = water use reduction expressed as a decimal fraction (the pumping restriction); and
prr = percentage of revenues to be recovered expressed as a decimal fraction. For this tariff, prr shall equal 0.5.

To implement the Temporary Water Rate, the Utility must comply with all notice and other requirements of 30 TAC 291.21(l).

#### METER TAMPERING, DAMAGE OR SERVICE DIVERSION PENALTY:

One time penalty per occurrence for tampering with or damaging a water meter or any appurtenance thereto including locks and meter boxes or service diversion of one hundred dollars (\$100.00).

### FRANCHISE FEE PASS THROUGH CLAUSE:

Charges a municipality makes for use of streets and alleys pursuant to Tax Code §182.025 or other applicable state law not to exceed 2% or the actual amount charged by the municipality shall be passed through utility-wide as an adjustment to the water gallonage charge according to the following formula:

AG = G + B, where,

AG = adjusted gallonage charge, rounded to the nearest one cent;

G = approved gallonage charge (per 1,000 gallons); and projected franchise fees payable (per 1,000 gallons).

Residential sewer service will be billed year round using that service connection's average winter water consumption during December, January and February. Single family residential service connections without a historic average will have an imputed average of 5,000 gallons until they have established an average. A new single family residential customer may request a true-up based on their first actual winter average for the months that an imputed average was applied. Such request must be made within 60 days of the billing date of the customer's first bill with their actual winter average. Multi-family residential service connections without a historic winter average will have an imputed average of 5,000 gallons per residential unit until they have established an average.

Non-residential service connections will be billed on actual monthly water consumption without the use of winter averaging.

These interim rates were agreed to by the parties as part of the settlement reached in Public Utility Commission Docket No. 45570, Application of Monarch Utilities I. L.P. to Change Rates for Water and Sewer Service.

B = change in purchased sewer service gallonage charge (per 1,000 gallons).
