PROOF OF REFUND DISBURSEMENT**

Monarch Utilities I, L.P., ("Monarch") files its Proof of Refund Disbursement and states as follows:

In its Final Order approving Monarch's application, the Commission required Monarch to refund \$1,500,000 to its ratepayers based on the agreed schedule and conditions set out in Attachment C to the Final Order. In its September 2017 billing cycle, Monarch refunded its customers with a one-time bill credit to active Monarch customers rather than over a 12-month period. A copy of the Affidavit of Refund Disbursement verifying the refund to customers is attached hereto.



AFFIDAVIT OF REFUND DISBURSEMENT

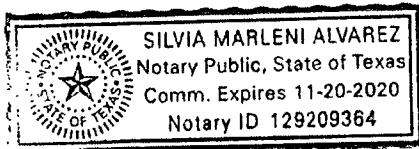
BEFORE ME, the undersigned authority, on this day appeared EDWARD TAUSSIG who being by me first duly sworn, on oath deposed and said the following:


1. My name is EDWARD TAUSSIG, I am the Finance Director for Monarch Utilities I, L.P. ("Monarch") the Applicant in the above-named application which was approved by the Public Utility Commission of Texas ("Commission"). My address of record is 12535 Reed Road, Sugar Land, Texas 77478. I am over 18 years of age, have personal knowledge of the facts recited herein, and am not otherwise disqualified from making this my sworn affidavit. The information provided herein is true and correct.
2. In the Commission's Final Order approving Monarch's application, Ordering Paragraph 4 required Monarch to refund to its ratepayers \$1,500,000 based on the agreed refund schedule and conditions set out in Attachment C to the Final Order. One of the requirements of Attachment C is that "At the end of the refund period, the amount refunded to customers shall be reported to the Commission."
3. As required by the Commission's Final Order, during the September 2017 billing cycle, Monarch refunded customers with a one-time bill credit to active Monarch customers as of August 31, 2017. Monarch elected to provide the refund to customers over one month rather than the twelve months required by the Commission's Final Order. The refunding process including adjustments was complete by November 21, 2017.
4. The actual amount of refund totaled \$1,500,051.76.
