I wish to be a commenter:

After living 2.5 miles away for 17 years and using the Johnson Country Rural Coop water utility! find that I now pay twice as much monthly for the Monarch Water Co at my new home at 3317 Twin Creeks Drive, Cleburne TX 76031.

We did not pay a base rate with the coop. we paid for usage, Now we pay a base rate plus usage and the service is not now nor has it been up to par with the service we had from the coop. There have been several days were there has been no water, once was for nearly 24 hours, and for the past couple of days there is so much air in the supply line than it is difficult to shower or flush. There have been many days of very low water pressure.

In every one of these incidents there is never an explanation, nor credit given. I do not see why there should be an increase in rates when there is no indication that this utility can offer the same or better level of service than offered during our 17 year history with Jo. Co. Rural Coop.
