I believe our community would be adversely affected by the sale to this particular buyer due to their lack of physical and financial resources necessary to maintain the system. I, and all community members I have spoken with support Mr. David Petty (current owner of the company) and his right to sell his company but just do not believe this buyer can or will support the needs of the community in a satisfactory manner. Mr. Petty has done an admirable job with the company he inherited from his mother's estate and I would support his sale to a buyer with sufficient resources to serve our community.
