#### COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Supplemental Recommendation on Administrative Completeness.

#### I. **Background**

On February 8, 2016, Aqua Texas, Inc. d/b/a Aqua Texas (Aqua Texas) filed with the Commission an application to amend its water certificate of convenience (CCN) No. 13203 and sewer CCN No. 21065 in Montgomery County, Texas pursuant to Texas Water Code §§ 13.242-.250 (TWC) and 16 Tex. Admin Code §§ 24.101-.107 (TAC).

On March 8, 2016, the Staff filed comments regarding administrative completeness and propose a procedural schedule. Staff's Supplemental Recommendation on Administrative Completeness provides the affidavits of notice that were inadvertently omitted from Staff's Recommendation on Administrative Completeness. Therefore, this pleading is timely filed.

#### Staff's Recommendation on Administrative Completeness II.

As detailed in the attached memorandum (Attachment A) of Patricia Garcia and Gary Horton, in the Commission's Water Utilities Division, Staff recommends the application be deemed administratively complete pursuant to TWC §§ 13.242-.250 and 16 TAC §§ 24.101-.107.

Staff further recommends Aqua Texas be directed to:

- 1. Provide the attached notice forms (Attachment B) of the application to the following:
  - a. any districts, groundwater conservation districts, counties, utilities, cities, cities with an extraterritorial jurisdiction within two (2) miles of the proposed service area;
  - b. any city with an extraterritorial jurisdiction which overlaps the proposed service area;

- c. landowners with more than 25 acres and any affected parties in the proposed CCN area. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN lies; and
- d. notice to the public which must be published once each week for two (2)
   consecutive weeks in a newspaper of general circulation in Montgomery County;
- 2. Provide notice to all of the entities listed
- 3. Include a copy of a map showing the proposed service area with the individual notices to neighboring utilities and other affected parties. It is Aqua Texas's burden to provide an accurate map delineating the proposed area with each individual notice. Information related to districts including addresses can be obtained by Aqua Texas from the TCEQ web site located at <a href="http://www14.tceq.texas.gov/iwud/">http://www14.tceq.texas.gov/iwud/</a>
- 4. File the attached affidavits (Attachment C) after providing notice.

### III. Proposed Procedural Schedule

Staff proposes the following procedural schedule:

Deadline for Staff to file an updated procedural schedule based upon the date notice was mailed	April 27, 2016

On February 8, 2016, Aqua Texas, Inc. d/b/a Aqua Texas (Aqua Texas) filed with the Public Utility Commission of Texas (Commission) an application to amend its water certificate of convenience and necessity (CCN) No. 13203 and sewer CCN No. 21065 in Montgomery County, Texas pursuant to Texas Water Code Ann. (TWC), §§ 13.242 to 13.250 and the 16 Tex. Admin Code (TAC) §§24.101 to 24.107.

A Staff review of the information filed by the applicant found that it is sufficient in the required application and mapping information. Therefore, Staff recommends that the application be deemed sufficient for filing and found administratively complete. Staff further recommends the following:

- 1) The Applicant be ordered to provide notice of the application to the following:
  - a. any districts, groundwater conservation districts, counties, utilities, cities, cities with an extraterritorial jurisdiction within two miles of the proposed service area;
  - b. any city with an extraterritorial jurisdiction which overlaps the proposed service area;
  - c. landowners with more than 25 acres and any affected parties in the proposed CCN area. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN lies; and
  - d. public notice which must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Montgomery County.
