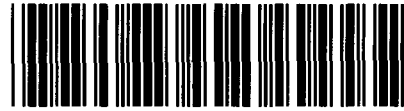

Re: PUC Docket No. 45601, SOAH Docket No. 473-16-2983, *Application of LCRA Transmission Services Corporation to Amend its Certificate of Convenience and Necessity for the Zorn – Marion 345-kV Transmission Line Project in Guadalupe County*

Dear Commissioners:

On September 15, 2016, the Public Utility Commission of Texas (Commission) issued a Final Order in Docket No. 45601 approving an amendment to LCRA Transmission Services Corporation's (LCRA TSC) certificate of convenience and necessity (CCN) to construct and operate a new critical 345-kV transmission line within Guadalupe County, Texas (the Project).

Subsequent to issuance of the order, LCRA TSC has worked expeditiously to obtain the necessary rights of way and to design and construct the Project in accordance with a schedule that will result in the Project being energized by May 2019. As of the date of this letter, LCRA TSC is pleased to report to the Commission that it remains on schedule to energize the Project as needed by May 2019.

The route approved for the Project was located on property owned or partially owned by Ms. Twyla Schroeder, Mr. and Mrs. Jason and Erin Christensen, and Mr. Archie Wohlfahrt—who appeared before the Commission on the day Docket No. 45601 was considered. Ordering Paragraph 10 of the final order required of LCRA TSC as follows:

10. LCRA Transmission Services Corporation shall work with Ms. Twyla Schroeder, Erin and Jason Christensen, and Mr. Archie Wohlfahrt to develop minor deviations of route 10M, consistent with ordering paragraph 9, on each of the their properties. LCRA Transmission Services Corporation shall inform the Commission of the status of the development of the minor deviations on the properties by providing filings in this docket.

Following issuance of the Final Order, LCRA TSC worked with Ms. Schroeder (and the co-owners of her property), Mr. and Ms. Christensen, and Mr. Wohlfahrt (and the co-owners of his property) to develop minor route deviations of the transmission line facilities on each of their respective properties. By delivery of this letter, LCRA TSC is pleased to inform the Commission that it has developed minor deviations to the approved route on the properties of Ms. Schroeder, Mr. and Ms. Christensen, and Mr. Wohlfahrt in accordance with the provisions of the Commission's Final Order.
