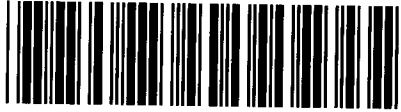



My agent and attorney-in-fact may act for me and in my name, place and stead to do and perform all acts, deeds, matters and things whatsoever necessary and advisable in the judgment of my said attorney-in-fact as fully and effectually to all intents and purposes as I could do if personally present and acting, for real property transactions in Panola County, Texas for real estate in Panola County, Texas.

Our Attorney-in-Fact has the power and interest to conduct any and all negotiations and agreements including the sale and mortgage regarding all our real property in Panola County, Texas.

This power of attorney is effective now and is not affected by my subsequent (later) disability or incapacity.

I agree that any third party who receives a copy of this document may act under it. Revocation of the durable power of attorney is not effective as to a third party until the third party receives actual notice of the revocation. I agree to indemnify the third party for any claims that arise against the third party because of reliance on this power of attorney.

If any agent named by me dies, becomes legally disabled, resigns, or refuses to act, I name the following as successor to that agent: Varnell H. Langford of Carthage, Texas.
