Your Honor and Ladies and Gentlemen:

In accordance with the PUC Intervenor Rules, we submit the following objections to the above referenced proposed Garland Transmission R-O-W, Route #4 that crosses our above referenced tract in Panola County, Texas:

1. The tract has been a long-time Certified Tree Farm, where its primary use has been timber production,
2. The tract already has approximately 16.5 acres of utility rights-of-way and well sites on the property and the proposed transmission line r-o-w will take another estimated 15 acres (150' X 4,500') of prime timber land out of production (see attached aerial photo),
3. These approximately 31.5 acres of rights-of-way would then total more 14% of the land on the 226-acre tract
4. Utility rights-of-way remove the land from timber production forever, unlike pasture land, which can be reused when the power line construction is finished, and
5. The addition of another large r-o-w will further diminish the value of the property and reduce the timber value, due to reduction in number of acres in timber volume being produced, and
6. The construction and maintenance of the R-O-W could have a negative effect on the adjacent Wetlands easement, currently being managed by the USDA-Natural Resource Conservation Service (NRCS).
