Request to Intervene in PUC Docket No. 45624 Teresa R. Stein

Purpose: Intervention request in the construction of a proposed double circuit, 345-KV transmission line that will begin at a new Oncor Electric Delivery Company switching station(s) in Rusk and Panola Counties, Texas.

Major Concerns:

- If PUC Docket 45624 moves forward with the proposed construction of the transmission line, I expect to be compensated for damages to the land itself, equipment on the land, right of way, natural gas lines and timber. This also includes, but is not limited to any other factors that negatively impact the land directly/indirectly with respect to the construction of the transmission line.
- Currently, there are natural gas lines on the property and have been in place for years.
 Construction of the transmission line could pose a <u>safety concern</u> if the transmission line is installed in the location of the natural gas line.
- The transmission line could pose an undue hardship to neighbors, thereby creating a hazardous/toxic living environment, illnesses, health and safety issues for neighbors.
- PUC Docket 45624 will also negatively impact any future capital improvements deemed necessary to the land.

Deliverables/Follow-up: Request the following questions be addressed.

- Due to the construction of the transmission line, will affected property owners be compensated for damages to:
 - o The land itself?
 - o Equipment?
 - o Right of way?
 - o Timber?
 - o Gas lines?
- How will the transmission line affect the safety and well-being of neighbors and the environment?
- How will the transmission line impact the natural gas line already in place?
- What is the noise level of the transmission lines?
