6.2 ENTIRE AGREEMENT

This Agreement may be modified or amended only by a written instrument duly authorized and executed by the parties.

6.3 COUNTERPARTS

This Agreement may be executed simultaneously in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument. It is not necessary that all parties execute any single counterpart if each party executes at least one counterpart.

The parties are not relying upon any representation, warranty, contract, promise or information, written or oral.

6.6 GOVERNING LAW

This Agreement shall be construed in accordance under the laws of the State of Texas.

ORDER

An application by Charles Branch d/b/a Doucette Water System ("Applicant") for an increase in retail water rates in Tyler County, Texas was presented to the Executive Director of the Texas Commission on Environmental Quality ("Commission") for approval pursuant to Section 5.122 of the Texas Water Code ("Code").

Applicant provides water service in Tyler County, Texas and is a retail public utility as defined in Section 13.002(19) of the Code.

On June 21, 2002, Applicant filed an application with the Commission for an increase in retail water rates charged to its customers in Tyler County, Texas. The application was accepted for filing and assigned Application No. 33967-G. Notice of the rate change with a proposed effective date of August 19, 2002 was provided to the customers on June 12, 2002, by the Applicant. The

notice of the rate increase complied with the notice requirements of Section 13.187 of the Code and 30 Texas Administrative Code ("TAC") Section 291.22 and was sufficient to place affected persons on notice of the proposed rate increase. The Commission received requests for a public hearing on the application from more than 10% of the customers.

Honorable Kerry Sullivan, an Administrative Law Judge ("ALJ") with the State Office of Administrative Hearings ("SOAH"), conducted a preliminary hearing on November 18, 2002, during which he assumed jurisdiction and designated the following parties: Applicant, represented by Charles Branch; Rev. Michael Hadnot and Debra A. Sullivan ("Protestants/Ratepayers"), representing themselves; the Executive Director of the Commission ("Executive Director"), represented by Geoffrey P. Kirshbaum; and the Public Interest Counsel of the Commission ("PIC"), represented by Scott Humphrey.

At the preliminary hearing, the parties requested to abate the contested case hearing in this matter until January 17, 2003, in order to accommodate an attempt to mediate the dispute. In his November 21, 2002, "Order No. 1 Confirming Action Taken During Preliminary Hearing," the ALJ granted the motion and directed the parties to file either an agreed motion to dismiss or a status report and proposed procedural schedule by January 17, 2003.

A mediation by the Commission's Alternative Dispute Resolution ("ADR") Office was tentatively scheduled for January 9, 2003. However, prior to that time, the parties reached a settlement agreement in principle on the rates to be charged by Applicant. Therefore, no formal mediation was held or rescheduled. The parties and the assigned Commission ADR mediator continued to work toward execution of a final settlement agreement agreeable to all parties. The Executive Director informed the ALJ of this development in the January 28, 2003, "Status Report No. 1."

On March 26, 2003, the parties filed a Mediated Settlement Agreement signed by all parties that reflects agreed upon rates and effective dates. As part of the agreement, the parties agreed that this matter could be remanded by the ALJ to the Executive Director for processing as an uncontested matter and the Protestants/Ratepayers agreed to withdraw their protests of the Applicant's water rate/tariff change application. In his March 27, 2003 "Order No. 2 Remanding Docket," the ALJ dismissed this case from SOAH's docket and remanded the application to the Executive Director for disposition as an uncontested matter.

The rate structure agreed to by the designated parties, to be effective January 19, 2003, is just, reasonable and adequate to allow the utility to recover its costs of providing water service, as required by Sections 13.182 and 13.183 of the Code. The agreed upon rates are embodied within the attached rate tariff.

NOW, THEREFORE, BE IT ORDERED BY THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY that:

- 1. The rate increase for Charles Branch d/b/a Doucette Water System shall be approved as listed on the attached rate tariff. Year one rates shall be effective January 19, 2003, and Year two rates shall be effective January 19, 2004.
- 2. Unless previously provided, Charles Branch d/b/a Doucette Water System shall provide written notice of the final rate structure approved in this proceeding to all affected customers with the next billing cycle after issuance of this Order.
- 3. Charles Branch d/b/a Doucette Water System's TCEQ application in this matter shall be amended to reflect the rates for Year one and Year two set forth in the attached rate tariff.
- 4. The effective date of Year one rates shall be January 19, 2003, and those rates shall remain in effect for twelve (12) consecutive monthly billing cycles thereafter. Year two rates shall become

effective on January 19, 2004, and shall remain in effect for at least twelve (12) consecutive monthly billing cycles thereafter. After January 19, 2005, the Year two rates will remain in effect until such time as another rate change for the Charles Branch d/b/a Doucette Water System may be authorized by the Commission.

- 5. No customer refunds shall be distributed by Charles Branch d/b/a Doucette Water System for rate charges collected from its customers for water service provided on or after August 19, 2002, and prior to January 19, 2003.
- 6. Charles Branch d/b/a Doucette Water System's water rate/tariff change application shall not be changed, amended, or modified in any manner not specifically set forth in this Order.
- 7. Effective January 19, 2003, Charles Branch d/b/a Doucette Water System shall take the following actions:
 - a. Notify its customers of its water line flushing schedule by posting the schedule outside and at the front of its main business office in Woodville, Texas, such that customers who wish to obtain advance notice of this information may do so easily by stopping by the office and viewing the posted schedule;
 - b. Submit to the Commission within 90 days signed, sealed and dated as-built plans and specifications for modifications made to the Doucette Water System in compliance with 30 Texas Administrative Code ("TAC") § 290.39(j) (TCEQ Public Water System rules), including such plans and specifications that relate to the installation by the Applicant of a 22,000 gallon ground storage tank and all modifications the Applicant has made to the distribution system; and
 - c. Submit to the Commission within 90 days documentation showing that the used 4,000 gallon pressure tank installed in the Doucette Water System was previously used for

potable water service only, in compliance with 30 TAC § 290.43(c)(9) (stating that a letter from the previous owner or owners must be submitted to the Commission which states the use of the tank).

The Chief Clerk of the Texas Commission on Environmental Quality shall forward a copy of this Order and tariff to the parties.

If any provision, sentence, clause, or phrase of this Order is for any reason held to be invalid, the invalidity of any portion shall not affect the validity of the remaining portions of the Order.

Notice of the rate change with a proposed effective date of November 25, 2002, was provided to the customers on September 17, 2002, by Lakeside Water Supply. The notice of the rate increase complied with the

notice requirements of Section 13.187 of the Code and 30 Texas Administrative Code ("TAÇ") Section 291.22 and was sufficient to place affected persons on notice regarding the proposed rate increase. The Commission received requests for a public hearing on the application from more than 10% of the customers.

Sharon Cloninger, an administrative law judge of the State Office of Administrative Hearings, conducted a preliminary hearing on July 22, 2003, and designated the following parties: Applicant represented by Charles Branch; the Executive Director of the Commission represented by Sheridan L. Gilkerson; the Public Interest Counsel of the Commission represented by Eric Allmon; and protestant Paul Wilson.

After informal negotiations, the designated parties negotiated a settlement and agreed upon the following water rate: \$30.00 for the first zero gallons and \$2.90 per 1000 gallons thereafter. They also agreed that there will be no refunds of monies collected from the higher increase that the Applicant instituted on November 25, 2002, and that the new rate would go into effect on June 25, 2003. The protestant withdrew his protest and requested that the matter be remanded to the Executive Director for administrative processing of the agreed rate. On July 29, 2003, Judge Cloninger remanded the matter to the Commission for approval by the Executive Director.

The rate structure agreed to by the designated parties, effective June 25, 2003, is just, reasonable and adequate to allow the utility to recover its costs of providing water service, as required by Sections 13.182 and 13.183 of the Code. Attached is a tariff reflecting the agreed upon rates.

NOW, THEREFORE, BE IT ORDERED BY THE Texas Commission on Environmental Quality that:

- 1. A rate increase for Lakeside Water Supply will be approved as listed on the attached rate tariff page, effective June 25, 2003.
- 2. Unless previously provided, Lakeside Water Supply shall provide written notice of the final rate structure approved in this proceeding to all affected customers with the next billing cycle after issuance of this Order.

The Chief Clerk of the Texas Commission on Environmental Quality shall forward a copy of this Order and tariff to the parties.

If any provision, sentence, clause, or phrase of this Order is for any reason held to be invalid, the invalidity of any portion shall not affect the validity of the remaining portions of the Order.
