## AQUA TEXAS' STATUS REPORT AND REQUEST FOR EXTENSION

## TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, Aqua Texas, Inc. d/b/a Aqua Texas ("Aqua") and files this Status Report and Request for Extension. In support thereof, Aqua would show the following.

On February 24, 2016, Aqua and Montgomery County Municipal Utility District No. 126 (MUD 126) filed an application for approval of a service agreement under Texas Water Code § 13.248 (TWC), which would transfer a portion of Aqua's water certificate of convenience (CCN) No. 13203 and sewer CCN No. 21065 service areas to MUD 126, and to decertify a portion of Aqua's water CCN No. 13203 and sewer CCN No. 21065 in Montgomery County. On May 31, 2016, Order No. 4 was issued providing that by June 27, 2016, Aqua shall supplement the application or file a status report. Therefore, this pleading is timely filed.

Aqua has compiled all necessary supplemental information in the form requested by Staff, but requires a few more days to gather signature pages and prepare the complete package for filing. Therefore, Aqua requests a 3-day extension of the procedural schedule established in Order No. 4 to allow sufficient time to complete these tasks. Commission Staff is not opposed to this request.

Aqua respectfully requests that the following deadlines be included in the a new procedural schedule.

Deadline for Aqua to supplement the application or file a status report

June 30, 2016

Deadline for Commission Staff's recommendation regarding the administrative completeness of the amended application, along with a proposed procedural schedule and comments regarding whether the application is appropriate under Tex. Water Code § 13.248.
