#### Consideration:

Cash and other good and valuable consideration, including but not limited to the covenants, agreements, promises, and releases in that certain Compromise and Settlement, Mutual Release, and Amendment and Restatement of Operations and Maintenance Agreement between Buyer and Seller, dated effective as of January 1, 2016.

#### **Transferred Properties:**

All of Seller's interest in the rights and privileges appurtenant to Seller's right to provide water and wastewater service in and to the approximately 175 acres of land located within the boundaries of Buyer, specifically including those portions of water Certificate of Convenience No. 13203 and sewer Certificate of

Convenience and Necessity No. 21065 (referred to herein, collectively, as the "<u>CCNs</u>") which lie within the boundaries of Buyer.

This Bill of Sale memorializes the transfer contemplated by Section 4 of the Compromise and Settlement, Mutual Release, and Amendment and Restatement of Operations and Maintenance Agreement between Buyer and Seller. This Bill of Sale is executed to effectuate the CCN Sale Transfer Merger Application filed with the Texas Public Utility Commission under Docket Number 45656. The parties acknowledge and agree that there are no customers and no deposits to be transferred as part of this CCN Sale Transfer Merger transaction.

Seller, for the Consideration recited above, hereby, sells, transfers, and delivers the CCNs to Buyer, together with all and singular the rights and appurtenances thereto in any way belonging, to have and to hold the CCNs to Buyer and Buyer's employees, agents, representatives, successors, and assigns forever. Seller binds Seller and Seller's employees, agents, representatives, successors, and assigns to warrant and forever defend all and singular the title to the CCNs to Buyer and Buyer's employees, agents, representatives, successors, and assigns against every person whomsoever lawfully claiming or to claim the same or any part thereof.

When the context requires, singular nouns and pronouns include the plural.
