BRIEFING ORDER AND RECORD CLOSE DATE**

The undersigned Administrative Law Judge (ALJ) is now the only ALJ assigned to this case. The hearing was convened and adjourned on January 17, 2017. The parties agreed to and the ALJ approved the following deadlines and page limits:

Proposed findings of fact, conclusions of law, and ordering paragraphs, if any	February 28, 2017	No page limit

The page limits apply to the brief's text and any attachment that is in the nature of legal argument, such as a table or appendix summarizing evidence or discussing law. The page limits do not include the signature page or material, if any, such as a table of contents or non-native attachment such as a copy of a legal authority that is not easily obtained. The parties will try to agree on and file stipulations of uncontested facts. If such stipulations are reached, they may be filed at any time up to and including February 28, 2017, and no page limit applies to them. The record closes on February 28, 2017.

Promptly after filing any initial or reply brief, stipulations, or proposed findings of fact, conclusions of law, or ordering paragraphs, if any, each party shall email a copy of its filing in Word format to [Erin.Hurley@soah.texas.gov](mailto:Erin.Hurley@soah.texas.gov). The parties are also encouraged to email to

Ms. Hurley a Word copy of the version of their testimony that is in evidence (excluding exhibits unless it is easier to email both). The emails to Ms. Hurley should state the docket numbers of this case. The electronic name of each document attached to the email should state what the document is (e.g., [party name] initial brief).
