Dear Judge Drews,

It has come to my attention that while the City of Cibolo's ("City") Proposed Findings of Fact and Conclusions of Law ("FOF") were filed at the Public Utility Commission ("Commission") at 2:59 p.m. yesterday, the City's Reply to Initial Briefs ("Reply") in this matter was not filed until 4:26 p.m. that afternoon.

The courier service we employed picked up both the FOF and Reply from my office at approximately 2:40 p.m. and arrived at the Commission at 2:50 p.m., prior to the filing deadline and with enough time to make both filings in a timely manner (as evidenced by the file stamped time on the FOF). However, for reasons I do not understand, the courier only filed the FOF with the Commission, yet filing both the FOF and Reply at SOAH. I had left the office for another out-of-town meeting yesterday afternoon, but when my support staff realized that the courier had not filed the Reply at the Commission, they immediately went back to the Commission themselves to file the Reply.

The courier's actions were entirely contrary to our written instructions to file the Reply and the FOF at the Commission first, before 3:00 p.m. Attached is a copy of our courier request slip which shows the delivery instructions (the purple ink on the request form is the courier's notes). I have no explanation for why the courier acted as he did.

There is no prejudice to any party in this proceeding by this unfortunate situation, as (i) the version of the Reply that was filed at the Commission was the same version that was initially provided to the courier at 2:40 p.m., (ii) all parties in this matter were electronically served with a copy of the Reply prior to 3:00 p.m. (such emails are also attached hereto), and (iii) there are no responsive briefs to the Reply. I apologize for the delay in this filing and respectfully request Your Honor to accept the filing.
