GREEN VALLEY'S RESPONSE TO ORDER NO. 10 AND UNOPPOSED MOTION FOR CONTINUANCE

COMES NOW, Green Valley Special Utility District ("Green Valley") and files this Response to Order No. 10 and Unopposed Motion for Continuance.

On June 29, 2017, the Public Utility Commission of Texas issued an Interim Order in this case. On June 30, 2017, SOAH Order No. 10 Discussing Deadline and Procedures; Notice of Prehearing Conference was issued setting July 20, 2017 as the deadline for parties to file a joint listing of all remaining issues in the case and setting a prehearing conference for 1:00 p.m. on July 24, 2017.

Green Valley respectfully requests a continuance of the deadlines set by the Administrative Law Judge in Order No. 10. Counsel for Green Valley is scheduled for a hearing on the merits on July 25-28, 2017 and a prehearing conference on July 20, 2017 in PUC Docket 46256; SOAH Docket 473-17-1641.WS; Application of Liberty Utilities (Tall Timbers Sewer) Corp., Liberty Utilities (Woodmark Sewer) Corp. and Liberty Utilities (Sub) Corp. to Change Rates for Sewer Service in Smith County, Texas. Counsel for Green Valley will be preparing for the hearing on the merits and unavailable for the prehearing conference in this docket on July 24, 2017. Additionally, Green Valley's board of directors needs additional time to meet and consider the remaining issues in the case. Their next board meeting is currently scheduled for July 27, 2017.

For these reasons, Green Valley respectfully requests that the deadline for parties to file their joint listing of issues be extended until August 3, 2017, and the prehearing conference be continued until August 10, 2017.

Counsel for Green Valley has conferred with counsel for the City of Cibolo and Commission Staff. Neither are opposed to the requested relief.

PRAYER

Green Valley Special Utility District respectfully requests that the Honorable Administrative Law Judge issue an order approving Green Valley's request for a continuance and set a deadline of August 3, 2017 for parties to submit their joint list of issues and continue the prehearing conference until August 10, 2017.
