**CITY OF CIBOLO'S RESPONSE TO ORDER NO. 7 ESTABLISHING DEADLINES-
PETITIONING FOR THIRD QUALIFIED INDEPENDENT APPRAISER**

COMES NOW, the City of Cibolo (the "City") and files this its Response to the Administrative Law Judge's Order No. 7 Establishing Deadlines. This Order No. 7 directs the parties to notify the Commission on or before July 14, 2016 as to whether their appraisers were able or unable to agree on a determination before the 16th business day after the date of their first meeting under this subsection, and whether the Commission needs to appoint a third qualified independent appraiser to reconcile the appraisals of the two originally appointed appraisers. This Response is timely filed.

The appraisers for the City and Green Valley Special Utility District ("GVSUD") met on June 21, 2016, and the City hereby notifies the Commission that they have been unable to reach an agreed determination. Consequently, the City hereby petitions the Public Utility Commission to appoint a third qualified independent appraiser to reconcile the appraisals of the City and GVSUD's originally appointed appraisers. Counsel for the City has spoken with counsel for GVSUD, and counsel for GVSUD does not oppose this petition.
